Role call performed and a quorum was in attendance.

Winter meeting minutes: Winter meeting minutes were approved unanimously.

Discussion on the Status of Routt County Search and Rescue:

- Chad Bowdry indicated that Routt County Search and Rescue will not be performing their
 reaccreditation this year. They would like to be considered for an Associate Membership.
 They are down to 23-24 members and they are struggling to put in the time necessary for
 reaccreditation. They are working on a new member class to build up members.
- Greg Foley brought up the possibility of not dropping the entire reaccreditation but to consider reaccrediting in a couple of the disciplines.
- Chad Bowdry indicated that they might consider doing a vote for associate membership at the Winter region meeting.
- Recommendation on waiting on voting on associate membership until the Winter Region meeting. This allows Routt eight months to do a partial accreditation in the Fall.
- Paul Woodward noted that Routt County is full accreditated through 31 December 2015. He
 recommends doing one or two reaccreditation disciplines to stay in the schedule.

 Chad Bowdry will take the suggestions back to Routt to discuss this and hold off on the vote until December 2015.

Albuquerque Police Department Ex Oficio Membership:

- Andy Simmons indicated that Albuquerque Police Department (APD) approached Albuquerque Mountain Rescue Council (AMRC) about becoming and ex oficio member of the Mountain Rescue Association. The police department wants to become more of a technical team. They currently have an open space team. The APD expressed a desire to join a national organization to become connected to the national conversation. APD has city and county jurisdiction as the first in team to the mountain. AMRC is a state resource. They work with APD as mutual aid. APD does not charge for their services. APD has done some scree and have been training with high angle. They do very little winter SAR activities. AMRC will continue to work with APD.
- Nobody present at the meeting had any issues with the concept of APD becoming ex oficio members.

Forest Service Permits:

- Greg Foley indicated that Douglas County Search and Rescue (DCSAR) had been approached by
 Forest Service employee, Nick Schrade, while they were on Berthoud Pass. Nick Schrade was not
 in uniform and was in a personal vehicle. Nick asked DCSAR whether they had a special use
 permit. Nick is from the Sulfur District out of Granby.
- Scott Messina stated that part of the reaccreditation process should be to determine whether or not we need to get a permit.

- Chad Edwards indicated that part 251 of the federal regulations, evaluated in 2004, was trying to minimize permits if they are not necessary to the management of the forest.
- Paul Woodward suggested going through the Sheriff.
- Larimer provides the Forest Service a heads up but does not get a permit.
- Paul Woodward offered to assist in this particular instance.
- Greg Foley will send out an email giving people a heads up.

MRA Conference Scholarship Money:

• Chad Edwards indicated that their is scholarship money available to help people attend the MRA conference. There has been only one application so far. More money is available.

Accreditation/Reaccrediation Guidelines:

- Alison Sheets would like more clarification in the guidelines for the number of attendees to accreditations. We need to consider balancing between the different reaccreditations for the year. 30 people per day might be too excessive.
- There is a conflict between limiting the group size and providing opportunities for people to meet the requirements to become scenario leads.
- One possibility is to limit the number of observers from Associate Members if they are not moving towards accreditation.
- Chad Edwards recommends self policing by the teams. Lead Evaluators have the authority and Chad recommends keeping the same guidelines for the time being.

Reaccreditation Supplies:

- Paul Woodward suggests that the region consider using region funds for accreditation supplies. His suggestion is for things like transceiver dummies and for training signs.
- Scott Messina and Paul Woodward will come up with some avalanche dummy options.

Authorization of Funds:

- Motion to reimburse Alison Sheets for purchasing of supplies used during the reaccreditation of Alpine Rescue Team.
